Focus will be in the Village of Canton to conduct a market analysis on Gouverneur Street, Riverside Drive and the County Highway area. Councilman LaMarche stated he would consider revisiting the locations after Supervisor Button returns from the annual meeting of the New York State Association of Towns on February 19-21 and meets with a particular property owner.

Philips asked the board to consider authorizing to hire a Court Security Officer who would have the power to carry a firearm. After discussion the board authorized Supervisor Button to find the funds to pay a Security Officer \$15.00 an hour at an average of 12-15 hours a month. Also Judge Philips and Judge Monroe will appoint that Officer.
